BSBI Recorders' Conferences

We held two one-day conferences in Scotland during April on the theme of Atlas 2020. Members and Recorders enjoyed a varied programme of talks variously on Atlas 2020, MapMate, the BSBI Database (DDb) and the Millennium Seed Bank Project. There was also a round-up of reports from the Vice-Counties and a general discussion and Q&A session. The highlight however was a beautifully illustrated talk on Stoneworts by Nick Stewart. BSBI MapMate

We are not aware of anyone having problems with MapMate running on Windows 10 that weren't already present in an earlier version of Windows (like 8 or 8.1) which they then upgraded to Windows 10. We *think* it runs absolutely fine on new Windows 10 machines. But before we make any recommendations on Windows 10 it would be useful to know who *does* have problems with MapMate not operating properly on *any* Windows operating system. We would like to try to resolve those problems (if possible) and it may help us give clearer advice on Windows 10. Please let us know straightaway if you have a problem with MapMate apparently not working properly, and we will be in touch. Threatened Plant Project – Update

<u>Peter Stroh</u> reports that the write-up of the Threatened Plants Project has been going well this winter, and we have now completed draft accounts for all 50 species surveyed. Our focus has now turned to writing the introduction and drafting chapters outlining the methodology and main findings, as well as getting into shape one main table that will condense all the relevant results of the survey for each species. In addition, we are now actively searching for external funding so that the TPP survey can be published as a book in addition to being available as an online resource.


BSBI DDb – New Ways to Search

<u>Tom Humphrey</u>, BSBI Database Officer reports that it is now possible to search for records by Recorder or place name (without selecting 'more options'). However, searching using grid references will usually return better results than by using place names.

Atlas 2020 Aquatics recording

I had a hunch that aquatics were being less well recorded for Atlas 2020 than non-aquatics, and asked Andy Amphlett if he could analyze data in the BSBI Database, to prove that. Andy writes "Analysis of the DDb does indeed show that across the whole of GB and Ireland, aquatics as a whole are less well recorded post 2000 than non-aquatics. For purposes of this analysis aquatics were defined as those taxa with Ellenberg indicator F (moisture) values¹ of 10 - 12, while non-aquatics had values of 1 - 9. The numbers of distinct taxon by hectad records pre-2000, and since 2000 were calculated using these two DDb queries for <u>non-aquatics</u> and <u>aquatics</u>.



For each vice-county, and for each of the two groups of taxa (aquatics and nonaquatics), the total number of post 2000 taxon by hectad records was calculated as a percentage of the pre-2000 total. 146 vicecounties have higher post 2000 percentage, meaning that they were better recorded, for non-aquatics than for aquatics. Only 7 vice-counties have aquatics with a higher post 2000 level of recording than nonaquatics, and these vice-counties have a low overall level of post 2000 recording."

For each article it is possible to view just the abstract or the references or to download the full article in HTML format (optimised for online viewing) or as a PDF (formatted as in the hard copy issue). Our license with Taylor and Francis permits BSBI members to save copies of articles for purely personal use, but obviously not to post them publicly. One VCR has suggested including all abstracts from a new issue in a copy of e-news. It would be interesting to know if there is general enthusiasm for this.
