#### **BSBI Recorders' Conference 2016**

A reminder that bookings are being taken for this year's Recorders Conference, to be held in Shrewsbury from Friday 2<sup>nd</sup> until Sunday 4<sup>th</sup> of September. More details can be found <u>here</u>. **Please note that the deadline for bookings is 15<sup>th</sup> of August, so book soon to avoid disappointment!** 

#### **Boundary Issues**

<u>Polly Spencer-Vellacot</u> raises two important issues about entering records near vice-county boundaries. First, if you use the sitename@grid\_ref quick method for entering a new site near the VC boundary, MapMate does not always assign the site to the intended VC. Second, the digitised VC boundaries in MapMate are not very accurate and there are discrepancies between them and those used by the BSBI Database (which are much more accurate). So even if the site is in the correct VC in your MapMate it might be just outside the more accurate boundary in the DDb, which will result in a DDb validation mismatch between the VC and grid reference.

In addition to ensuring you set up and use your GPS to give the most accurate readings possible (see the <u>GPS Advice</u> on the <u>Resources</u> page of the BSBI website) we therefore recommend that you take the following steps when recording near VC boundaries:

1. Plot site grid references that are very close to VC boundaries on a detailed map and check they are where you intended. The best online map is <u>www.cucaera.co.uk/grp</u>, which allows you to zoom in and out, displays GB VC boundaries and (using options) an OS, Satellite or Streetmap background. The <u>Grid Reference Lookup</u> tool in the <u>BSBI DDb</u> works in a similar way except that it doesn't have the 1:25,000 OS map background but at least it covers Ireland! Or, if available, use Memory Map with the VC boundary layer shown.

2. Check that boundary sites created by MapMate have the correct VC. In MapMate, if you usually only enter records in one county, you may have your defaults set to only show records from that county. You may need to go back to the main menu and click "View > My Configuration" to add neighbouring counties. You can then "Change Defaults" (in the Analysis window this is done using a little icon with a hand and a page) to allow you to search for records in neighbouring counties.

If you have accidentally entered a record with the wrong VC, you need to edit the **site**. This can be done by viewing the record, then clicking the blue text that says "site" and "view this entry". When you are viewing the **site**, you can click "record > edit record" and change the VC as you wish.

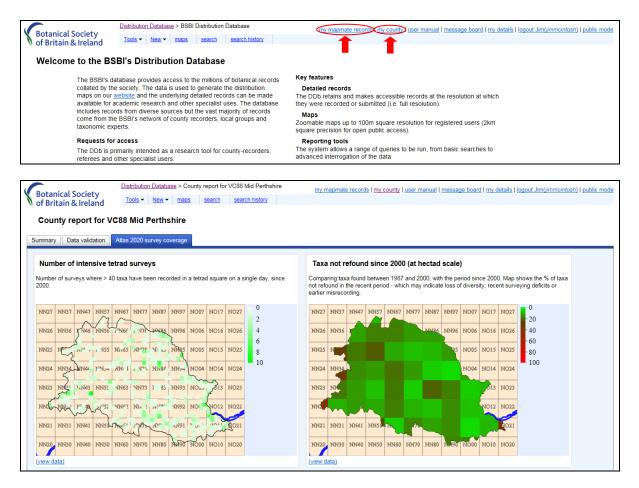
3. Finally, after each synch to the hub/DDb, watch out for any increase in the number of records listed as mismatched in the DDb > My County> Data Validation tab, "Grid-reference – vice-county boundary matching" section. And investigate and correct these mismatches. N.B. It is essential to make corrections in MapMate. The DDb will automatically be corrected after you next sync to it.

# Generating a list of taxa that have not been re-recorded post 2000 in boundary squares

More on using the <u>BSBI DataBase (DDb)</u> to generate a list of all the taxa recorded in a grid square (by clicking Tools > <u>Grid Reference Lookup</u>, typing the square reference, clicking look-up grid reference and clicking View taxon list for...):- <u>Tom Humphrey</u> has just added an option to the taxon list page to limit to a particular vice-county where the grid-square intersects multiple counties. This is really handy for Atlas 2020 re-recording. It means you can select to only see the taxa you have yet to re-record for your side of the VC boundary in the square. Take a look at <u>this</u> example.

# My county and my mapmate records

If you are a VC Recorder and use the <u>BSBI Database</u> – which I strongly recommend you do - when you log on you should see a tab at the top of the webpage entitled "my county" alongside "user manual", "message board", etc. This gives access to useful maps and analysis on Recording, Atlas 2020 coverage and Data Validation (example below). Let your Country Officer know if you can't see the "my county" tab, or if you would like any local members, who are already registered as DDb users, to also have access to it. This is another useful way to encourage Atlas 2020 recording, in addition to the above view taxon list feature.



Also, if you use MapMate and the BSBI Database, when you log on you should see the "my mapmate records" tab. It gives access to much useful analysis of your MapMate records. If it does not display then please let your Country Officer have a note of your CUK and ask for it to be enabled.

#### **MapMate Importing Spreadsheets**

Last month I recommended that small and infrequent contributions of records might be more easily made to County Recorders using the MapMate Importing Spreadsheets on the <u>BSBI Resources</u> page. Andy Amphlett, who developed the spreadsheets, points out that users <u>must</u> read and follow the simple instructions on the first tab *before* importing the records into MapMate.

### Callitriche palustris Records

<u>Peter Stroh</u> writes "I have been alerted by Ken Adams to a flurry of new records on the DDb for *Callitriche palustris* (the one with the black fruits). It is possible that some of the entries are data entry errors for *C. stagnalis*. Could you please check to see whether this applies to you? Equally, it would also be good to hear if some are not data entry errors, as this species, first confirmed as an addition to our flora in 1999, has only two localities in the last Atlas. The quick link to the latest DDb map is <u>here</u>. If you spot a similar mapping anomaly on the DDb for another species, it would be extremely helpful, as Ken did, to let me know. Data entry is fraught with danger; it is very easy to type in the wrong code or species name when entering loads of records."

### **Taxon Identification**

I mentioned the BSBI webpage devoted to links to help with Identification last month. Claudia Ferguson-Smyth writes "I worry about records of narrow-leaved **Pondweeds** whose stipules have not been carefully examined - a technique which requires some practice." The Plant Crib confirms that failure to do so is a common cause of misidentification and that stipules can only be seen with ease under a microscope. Here is a link to the full extract on <u>Potamogeton</u> from the Plant Crib on the <u>BSBI Identification</u> page.

I should have also reminded recorders to refer to <u>Notes on identification and some difficult and</u> <u>under-recorded taxa</u> (Stroh *et al*, 2015) which is on the <u>BSBI Atlas 2020</u> webpage, and was distributed with BSBI News last year to all members. This is a mine of useful information – including when to record aggregates, which species the aggregate includes and the recommended identification references. So, for example, "Unidentified **Callitriche** should be recorded as *Callitriche* agg. and not as *C. stagnalis*. We are fortunate that the identification of *Callitriche* in Britain and Ireland has been greatly aided by the publication of Lansdown (2008)." - The BSBI Handbook on Water-Starworts.

### **Taxon Identification - Stoneworts**

An excellent <u>handout</u> on Stoneworts has just been added to the BSBI <u>Identification</u> webpage. It includes a key to the identification of the most common species, sketches showing stonewort features, a list of species conservation statuses and a taxonomic list with synonyms (which I recommend you use to update your BSBI Charophyte Handbook). It was produced by Nick Stewart for the <u>Scottish Recorders' Conferences</u> this spring. Nick is repeating that presentation and running workshop sessions on Stoneworts at the <u>Recorders' Conference in Shrewsbury</u> in September.

# **Engler Medal for the Hybrid Flora**
