#### WHY IS OUR WORK NEEDED

Thanks to our tireless network of botanical leaders and recorders, we are one of the world's largest contributors of biological records: our data informs scientific research and underpins evidence-based conservation internationally. With a long and influential publication history behind us, and more than 10 new works planned for coming years already, BSBI will continue to pioneer evidence-based conservation as the future of the natural world takes centre stage in our time.

Without the BSBI and its volunteers, information such as the Red Lists of critically endangered plants would simply not exist; the 1 million plant records our volunteers contribute annually represent their dedication of time and skill. # YOUR WILL MAKING ONE AND INCLUDING BSBI

There are a large number of resources and sources of professional information on creating and maintaining a Will, including on the gov.uk website, via the Law Society, or the Institute of Professional Will Writers. As this leaflet is designed to give general information without taking account of individual circumstances, we recommend you seek professional legal advice.

#### THE TYPE OF GIFT

The most common gifts in Wills are of a residuary amount of your estate, or a fixed pecuniary amount, however specific gifts or assets, for example of bonds, a piece of art or property, are also welcome to be designated.

#### WORDING

The below suggestions can help your solicitor in recognising your wishes with respect to BSBI in your Will:

#### RESIDUARY

'I GIVE all [or a % share] of my Residuary Estate to the Botanical Society of Britain and Ireland (Registered Charity Number in England and Wales 1152954 and Scotland SC038675), 28 Chipchase Grove, Durham, DH1 3FA, to be applied for its general purposes...'

# PECUNIARY/ASSET

'I GIVE [the sum of \_\_\_\_\_ pounds/euro]/ [asset name] to the Botanical Society of Britain and Ireland (Registered Charity Number in England and Wales 1152954 and Scotland SC038675), 28 Chipchase Grove, Durham, DH1 3FA, to be applied for its general purposes...'

## 'and I/WE direct that:

the receipt of a proper officer for the time being of the Botanical Society of Britain and Ireland shall be a complete discharge to my/our Executors.

If before my death the above mentioned charity has changed its name or amalgamated with any other body then my Executors shall give effect to the gift as if it has been made to the body in its changed name or to the body which results from the amalgamation or to which the transfer has been made.'

#### SPECIFIC WISHES

If you wish to specify a narrower purpose for your gift, your professional advisor will be able to assist you in drafting a Letter of Wishes. Please do contact us as well so that we can advise on the most effective way to achieve your requests.





# FURTHER INFORMATION OUR CHARITABLE STATUS

Donations to charities in your Will are exempt from Inheritance Tax. Your professional advisor will be able to advise you on the implications of this on your Will and donations.
