Provisional Agenda

- 1. Chair's welcome, apologies for absence and opening remarks. The Chair will introduce those present beside him, drawing attention to the recent change of Honorary General Secretary, and describe the content and conduct of the meeting and the members' participation in it.
- 2. Approval of the Minutes of the last AGM. Members will be asked to approve the minutes of the third AGM of the Botanical Society of Britain and Ireland, held on 26 November 2016.
- 3. *Annual Review*. After a report by the Chair on the activities and outcomes during the year under review and of more recent achievements and future plans, members will be invited to adopt the fourth Annual Review of the Botanical Society of Britain and Ireland, covering the year ended 31 March 2017.
- 4. Annual Report and Accounts. A presentation will be given on the Annual Report and Accounts and other financial matters. Members will be invited to adopt the fourth Annual Report and Accounts of the Botanical Society of Britain and Ireland, covering the year ended 31 March 2017.
- 5. Independent Examiners / Auditors. If BSBI does not require an audit under company or charity law and none is requested by the members or Trustees, the Trustees will propose an appointment of an Independent Examiner. Otherwise, an appointment of an auditor will be proposed. The Trustees also seek approval to fix the remuneration of the Independent Examiner or Auditor.

The Chair will explain that Chris Metherell, a Trustee, who became President-elect at the 2016 AGM, automatically becomes BSBI President at the close of the 2017 AGM. Constitutionally, the BSBI President is also Chair of Council and to preserve independence, he will retire from the Board.
- 7. *Election of Trustees*. The meeting will be advised of other retirements and will be invited to elect Trustees to serve on the Society's Board.
- 8. *Election of Members of Council*. The meeting will be advised of retirements and will be invited to elect members to serve on the Society's Council.
- 9. *Election of Honorary members*. The meeting will be invited to elect Honorary members as proposed by the Board of Trustees.
- 10. Permanent Working and National Committees. A vote of thanks will be proposed for retiring and continuing members of the four Permanent Working Committees and the three Country Committees.
- 11. *Journal, Newsletters and BSBI Handbooks*. A vote of thanks will be proposed for the work of the Editor and Editorial Board of the *New Journal of Botany*, the editors of and contributors to *BSBI News*, the *Irish Botanical News*, *BSBI Scottish Newsletter*, and the *Welsh Bulletin*, and to the authors and editor of *Violas of Britain and Ireland*, BSBI Handbook no.17, published in March 2017.
